

ORDINANCE NUMBER V  
AN ORDINANCE FOR THE PRESERVATION  
OF THE SAFETY, SYMMETRY AND HEALTHFULNESS  
OF THE VILLAGE OF GEORGETOWN, IDAHO

- SEC 1.....THAT THE PLACING OF AWNINGS, SIGNS OR SIGNPOSTS, HITCHING POSTS OR ANY LIKE CONTRIVANCE PROJECTING OVER OR UPON THE HIGHWAYS MUST BE APPROVED OF BY THE BOARD OR SOMEONE AUTHORIZED BY THEM. ANY VIOLATION OF THE ORDINANCE SHALL BE PUNISHABLE BY A FINE NOT EXCEEDING \$100 IF NOT REMOVED AFTER FIVE DAYS NOTICE.
- SEC 2.....THAT IT IS HERE BY DECLARED A NUISANCE AND MISDEMEANOR FOR ANYONE TO LEAVE UPON ANY OF THE PUBLIC HIGHWAYS, ANY WAGON, VEHICLES WITH TEAMS ATTACHED THERETO TEMPORARILY OCCUPYING THE STREETS, OR TO MATERIALS USED IN THE CONSTRUCTION OF BUILDINGS OR PUBLIC WORKS. IN SUCH CASES OF WORK NOT MORE THAN ONE THIRD OF THE SIDE OF THE STREET SHALL BE OCCUPIED.
- SEC 3.....THAT IT IS HEREBY DECLARED A NUISANCE FOR ANYONE TO THROW OR DEPOSIT DEBRIS, FILTH, SLOPS, GARBAGE, STABLE OR BARN-YARD MANURE OR ANY OTHER MATTER WHATEVER UPON ANY OF THE PUBLIC HIGHWAYS, OR IN ANY OF THE WATER WAYS, EITHER ARTIFICIAL OR NATURAL. ALL PERSONS NOT COMPLYING WITH THIS ORDINANCE SHALL BE FINED NOT EXCEEDING \$100.
- SEC 4.....THAT NO ONE SHALL CONSTRUCT OR CAUSE TO BE CONSTRUCTED ANY outhouse, cesspool or privy in such a manner or place to be offensive to the neighbors or the dignity of the village. ALL SUCH PLACES MUST BE KEPT CLEAN AND DISINFECTED IN SUCH A MANNER AS TO GIVE RISE TO NO OFFENSIVE OR INJURIOUS SMELL OR ODOR. ANY PERSON OR PERSONS VIOLATING THIS ORDINANCE SHALL BE FINED NOT EXCEEDING \$100.
- SEC 7.....THAT IT IS HEREBY DECLARED A MISDEMEANOR FOR ANYONE TO DRIVE A HORSE OR VEHICLE UPON ANY PUBLIC SIDEWALK OR TO CROSS THE SAME EXCEPT AT THE REGULAR STREET CROSSINGS OR AT SUCH OTHER POINTS AS MAY BE PROVIDED. ALL PERSONS NOT COMPLYING WITH THIS ORDINANCE SHALL BE FINED NOT EXCEEDING \$100.
- SEC 8.....THAT IT IS HEREBY DECLARED A MISDEMEANOR FOR ANYONE TO DRIVE OR RIDE A HORSE OR OTHER ANIMALS IN A RECKLESS, WANTON OR CARELESS MANNER UPON ANY HIGHWAYS. ANYONE NOT COMPLYING WITH THIS ORDINANCE SHALL BE FINED NOT EXCEEDING \$100.
