LATER LLOYD WAS ELECTED TO REPRESENT BEAR LAKE COUNTY IN THE IDAHO STATE LEGISLATURE. HE BECAME THE MAN THE ENTIRE LEGISLATURE SOUGHT FOR ADVICE ABOUT IRRIGATION WATER LAW AND WATER RIGHTS.(DD)

WHEN IT WAS MILKING TIME UNCLE LLOYD WOULD OPEN THE PASTURE GATE. HE WOULD CALL HIS DOG AND TELL HIM "GO GET 'EM!" THAT DOG WOULD RUN THROUGH THE FIELDS THE SHORTEST WAY AND PRETTY SOON HERE CAME THE COWS UP THE LANE. THIS SAME DOG HAD A VERY MILD DISPOSITION. THERE WAS AN OLDER CAT IN THE BARN THAT USE TO 'BUG' HIM. HE WOULD GO UP TO IT, PUT HIS PA ON IT, HOLD IT DOWN, TURN HIMSELF AROUND AND SIT ON IT. THE CAT WOULD MEOOOOOOOOOW! AND HISS AND TRY TO SCRATCH, BUT TO NO AVAIL. AFTER AWHILE THE DOG WOULD GET UP AND WALK AWAY AS IF NOTHING HAD EVER HAPPENED. THAT WAS THE FUNNIEST THING TO SEE.(LLLLL)

AS A CHILD MIRLA LOVED TO WEAR OVERALLS (EVEN THE DISCARDED ONES OF HER BROTHER MYRON). MOST OF THE FARM WORK SHE LIKED TO DO BETTER THAN HOUSEWORK. SHE LIKED TO PLOW, HARROW AND DRIVE THE SLIP AND RICKER TEAMS. SHE'D CATCH AND CARRY LIVE MICE AROUND IN HER POCKETS.(H)

MIRLA ATTENDED TWO YEARS OF HIGH SCHOOL IN GEORGETOWN ID. SHE STAYED WITH HER SISTERS ELVA AND ARDATH IN MONTPELIER ID AND GRADUATED FROM MONTPELIER HIGH SCHOOL IN 1925.
